Refund Application HST Paid in Error Refund Based on Provincial Portion of HST

Eligibility Information

Refund is equal to the provincial portion of the Harmonized Sales Tax (HST) paid in error on a motor vehicle at the time of registration in Nova Scotia.

An applicant/purchaser must be able to provide satisfactory evidence that tax has been paid. The <u>Purchaser</u> of the motor vehicle is the **only party** entitled to a refund.

Documents required to be kept

All documentation supporting this rebate must be retained for audit purposes.

Instructions for completing the application

- 1. Give your details.
- 2. Provide details of the motor vehicle.
- 3. Provide the cost of the motor vehicle.
- 4. Attach a copy of the following document to support your application:
 - a. A copy of the Bill of Sale or Sales Invoice under which the motor vehicle purchased showing the purchase price, the HST paid, the name of the seller and buyer, the HST# of the seller and the make, model and year; **and**
 - b. A copy of the Registry of Motor Vehicles receipt showing the amount of the amount of the provincial component of the HST paid.

Note: Failure to supply the required documents may result in delays in processing or a denial of your application

- 5. Before submitting the refund application, review the application form to ensure that Sections 1, 2 & 3 are complete and that the certification in Section 4 is signed. Allow two to four weeks for processing. If your application is not complete, it will take longer.
